In point form and in no particular order, talking points from their presentation:

- Met great people at the public forum and was disappointed to not have had a chance to do a more structured presentation and question period as he felt it would have been more personal.
- wants the community to know that they are not a big faceless corporation. They live in Maple Ridge and have gravitated to and while exploring our area have come to love the Stave Falls area and are hopeful to provide a valuable service to the area.
- it will be the owners who operate the store. They also hope to hire up to 30 people from the area to work in their business
- They feel like they would be a good fit in the community.
- the building will be set off DTR and will have ground level signage that will be low key and in keeping

with the area. It will have an antique fell as Randy has a whole shed filled with old signs (like huge coke buttons) that he wants to have prominently displayed.

- the plan is currently for 8 pumps. Two for purple gas, one high dispensing pump and five regular pumps.
- They recognize there are reasons why people don't want this business to be located in the area, and has done research to figure out ways to make it work. They are seeking 'low impact' solutions to the issues our community has raised.
- He is happy to share that information with anyone who wants to see it.

There are 1st and 2nd readings coming up with the DOM and then there will be a public hearing. The Schmidt family have spent a significant amount of time, energy and money to bring the project as far as it has come and they are hoping to become a valuable part of and be able to invest in the community of Stave Falls.

Comment:

- there is a disconnect right now between the DOM and the residents of SF's and potential developers to our area. They pushed this on us before knowing there would be push back. They need to start engaging us as a community
