Question asked re Hosting and an annual fee for the running of the website. Birgit will reach out to Jen regarding the financial responsibilities for the website.
- 9. Membership: Should we waive the \$5 fee? Members present at tonight's meeting state not to waive the fee, rather push for a membership drive in the community. Bev will let us know if it is feasible to have the community sign in her front yard. Possibility of posting membership on mailboxes. Posting on social media. See further minutes regarding name change for SGCA for membership interest and meeting attendance. Anyone from the community can attend meetings, however only members in good standing can vote. Approach local businesses to see if there can be monetary incentives for our members
- 10. Invitation for Stave Falls PAC to attend SGCA meeting

PAC declined the invitation to attend tonight's meeting. A request was sent to the Stave Falls Elementary PAC to see what they are in need of for SGCA to donate money to. The request for

funds and to attend was turned down. They are awaiting to see what grants they may receive. A list of some items to ponder about for future donation was included in the response.

11. Setting up a Student Grant Birgit contacted Mission Foundation regarding the process in setting up a scholarship per previous meetings funds allocation. The allocation of 3 x \$500 scholarships was not encouraged as it is recommended to have a \$1000 plateau. Motion to have 2 x \$1000 scholarships rather than 3 x \$500 to be set in place by beginning of the next school year allowing for time setting the determining parameters for the recipients of the scholarships: Phil C
