Question:

Why would this association want to become a registered charity?

Answer:

Because as we move to have various things done on that land, we want other entities to pay for it. Whether it be government, or other organizations who have money that we can access, in some instances we must be a registered charity to qualify for that money.

Statement:

There are some community concerns that stated short term goals are being ignored in favour of the development of a facility. Parking is an issue, playground equipment is needed, the community wants to see more useable greenspaces but none of these are being considered.

Reply:

A survey was conducted to find out what the community would like to see happen on that parcel of land. It has always been this associations stated intent that not only can we work toward the construction of a facility on that land that the community will also be able to use, but that there are shorter term goals we would also like to achieve as stated in the survey.

It is not possible to begin the implementation of any part of these plans without having a master plan in place first that captures everything we hope to accomplish.
